3. It was unanimously resolved and accepted that the Present governing body shall represent for the year 2025.









NEW RULES & REGULATIONS OF (BDCA)

(w.e.f.n)

1. NEW FINANCIAL Year :

New Financial year for BDCA will be 1st April to 31st March.

2. MEMBERSHIPS / AFFILIATION :

All type of renewal Payments shall be paid before every 25th MARCH.

a) For Chess CLUBS/ACADEMIES Registration FEES :

- Each affiliated chess clubs/academies shall pay Rs. 2500/- every year.

b) COACH REGISTRATION FEES :

- Annual affiliation/membership fees of Rs. 1000/- to be paid for officiating chess coaching in the District.

c) ARBITERS REGISTRATION FEES :

- Annual affiliation/membership fees of Rs. 1000/- to be paid for officiating in chess tournaments in the District.

d) PLAYERS REGISTRATION FEES :

- Player Registration Fees Rs.350/-.

e) BDCA Memberships : There shall be two classes of members

1. **Patrons :** The executive committee may approve any person as a patron of the association on donation of lumpsum of Rs.50000/-(Rs. Fifty thousand only) and above.

2. BDCA membership Rs.1000/- yearly.

New Players/Members/Committee Members/ Patrons should submit along Xerox copy ID & address proof and Passport size photo or can be submitted online.

If Any BDCA member fails to renew then he/she will kept in inactive status & can become active after paying all previous dues.

3. ENTRY FEES of PLAYERS for various TOURNAMENTS :

FAIR



- For FIDE Rating Tournaments Entry Fees as per BDCA/AICF Rules.
- For Non-Rating Tournaments above 18 age as per convenience.
- For Inter-School/College Chess Tournaments below Rs. 1001/-
- For Universal Rating Entry Fees for each tournament will be between 0 to 21000/- only.

4. Organizing/Recognition FEES for District/Corporate Chess TOURNAMENTS :

- Universal Rating Tournaments -- Rs.5000/-
- FIDE Rating Tournaments -- As per AICF Rules.

5. REMUNERATION FOR ARBITERS :

- Fees as per AICF Guidelines for FIDE RATED Tournaments.
- In Bidar district for Non/Local Rating Rs.1000 (Transportation cost upto the venue + Food expenses and Accommodation will be paid per day if above 20 kms).

6. CHESS EQUIPMENT RATES as follows :

✓ **For Purchase**

- Chess Set : Rs.1000/- (Board + Coins)
- Chess Clock DGT 3000 : Rs.7200/-

✓ **ON RENT**

- Teaching Demo Board : Rs.100 Per Day.
- CHESS Set : Rs.10 Per Day.
- CHESS Clock : Rs.25 Per Day.
- Chess Tables : Rs.20 Per Day.
- Chess Chairs : Rs.10 Per Day.

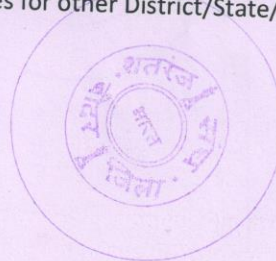
7. ADS / SPONSORS :

○ **FEES from SPONSORS :**

- **Daily Tournaments below 41 above Players:** Rs.1000 (Banner Size of 3.5 x 8 feet.) for Max.25 Tournaments.
- **For District/State/National Tournament:** Rs.5000 or above.
Banner sizes : 2 x 4 : Rs.3000
Banner sizes : 5 x 8 : Rs.12500

8. BDCA may announce some gifts to bidar players won (in past 2 year from previous December) in other state or within state other than bidar district and also provide expenses & entry fees for other District/State/National Chess Championships tournaments.

9. BDCA will provide Chess sets and Chess clocks for the any type of tournaments free of cost. The organizer has to collect it from BDCA office and return it immediately after the event.
- Charges for if any loss/damage to chess equipment/materials has to born by organizers to the association.

10. DELAY in RENEWALS :

If the organizers/clubs/academies/players are not aware or BDCA regulations due any genuine reasons then Penalty will be waved off but previous dues has to be cleared as previous norms & from current date all payments has to made as per latest guidelines of the association.

11. REQUEST of DOCUMENTS COPY:

If any member or player wants the copy of bye-laws can get from District Registrar of societies or download from website or from BDCA office by paying Rs.35/- Per Page.


12. Chess Education & Play Daily Fees :
